Nashik: Short film "Chirbhog" by city-based director Nilesh Ambedkar has won the first prize in a competition organized by the National Human Rights Commission.

The 10-minute film revolves around a child facing caste- and vocation-based discrimination in a rural area. Humiliated, the child decides to use education as a tool to deal with the injustices in his life. The film will get a prize of Rs 2 lakh for winning the NHRC's eighth Short Film Competition On Human Rights. This is Ambedkar's second consecutive award. Last year, his film "Munghyar" won the third prize in the same

The society expects him to continue the caste-based profession that his family has done traditionally even though it is looked down on. He wants to end it all," said Ambedkar.

"Munghyar" dealt with the subject of "jant panchayats", and showed how they rule the community, force child marriages upon its members and ostracize families that don't agree to their terms.

Both films were shot in Igatpura taluka of Nashik district and were made on a budget of Rs 2 lakh each.

"We are proud that we were able to deliver the message bright and clear across the world that there are serious issues that need immediate attention for the better of our country," Ambedkar added.

Ambedkar, who produced "Chirbhog" with Rahul Sonawane, runs an NGO in rural areas of Nashik. The ideas for both films originated from here, he said.

"There are numerous social issues that the downtrodden people face, but

they stay hidden from the mainstream as they do not have a saleable value," said Ambedkar, adding that the lead of "Chirbhog", Yashwant, is in a similar situation.

"He witnesses discrimination against his parents by upper caste people in the villa
