Report of the activities of Legal Aid Clinic and Legal Literacy Centre Academic year 2022-23

Students are working as paralegal volunteers for various activities of District Legal Services Authority, Nashik.

The students participated in following activities of DLSA:-

- Students worked as paralegal volunteers in organization of National Lok adalat held on 11 February 2023 and also from 1 December to December 2023. Students got first-hand experience of seeing the pleadings and case papers. They got the opportunity to work under supervision of Secretary, DLSA.
 Nashik
- 2) Students worked as paralegal volunteers in actual working of National Lokadalat on 11 February 2023 lokadalat and December 2023. They helped the panel members, litigants and staff. They got the opportunity to observe the actual working in National Lokadalat and settlement of disputes. The students also worked for about 15 days with court staff for preparations of lokadalat. Thereby students got the opportunity to see the pleadings and other papers in court.
- 3) Students conducted the survey of prisoners as per the instructions of Hon'ble High Court under the guidance of DLSA from 1st November 2022. They got the questionnaire filled up for prisoners.
- 4) The paralegal volunteers worked for DLSA probono base to find cases and scrutinize data from CIS application.
- 5) The Legal Aid Clinic of the college is run by students and full time and visiting teaching faculty. Every Friday and Saturday the needy people from society can approach the Legal Aid Clinic for legal advice. The students get opportunity to interact with clients, advise them under supervision of teachers.
- 6) Various legal literacy programs are organized by the clinic for senior citizens, villagers with low income gr., general public, rotary clubs etc. The various subjects related to their day to day life were discussed in it. Their questions were answered and wherever necessary needy people were directed to approach DLSA for free Legal Aid.
- Our teachers work as External members for ICC of various institutions including Nashik District and Sessions Court.
- 8) The lectures and guidance of senior practicing advocates is organized for practical training of the students.
- 9) Trial education program is regularly organized for practical training of the students.
- 10) Visit to different courts, from Supreme Court to Consumer courts, Labour courts, Registrar office, Forensic laboratory etc. are organized for practical training.
- 11) Various memorable days are celebrated for imbibing the constitutional and professional values and competency. Co-curricular and extracurricular activities are also organized for it.
- 12) Students are guided for most court activities. E-journals are made available in the library. Students are given E-library facilities.

Visit to Bar Council of India




Place - Supreme Court New Delhi


